*ASSUMPTION OF THE RISKS AND WAIVER OF LIABILITY
RELATING TO Coronavirus/COVID -19*

The novel coronavirus (COVID-19) has been declared a global pandemic by the World Health Organization (WHO). COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state and city governments and health agencies have recommended frequent handwashing, wearing masks to cover your nose and mouth, and avoiding close contact with others (physical distancing). Guidelines have also been promulgated which limit the number of people from separate household from gathering in large groups. Although these restrictions may vary over time, all health officials view it essential to maintain physical distancing of six feet or more and the wearing of masks when in public places.

The Glass Fusion Collective, Inc. (Collective), has attempted to reduce the spread of the COVID-19 at its facilities by limiting the number of participants in its activities, insisting that all participants wear masks at **all times while engaging in Collective activities**, cleaning surfaces, etc. However, the Collective cannot guarantee that its membership or **YOU** will not be exposed to or become infected with COVID-19 while participating in its activities. Furthermore, given the layout and purpose of the Collective's studio and facilities, your presence at the Collective facility/facilities **may actually increase your risk of exposure to COVID-19** and subsequently the risk to those persons you come in contact with, including your family and household members.

By signing this agreement, **YOU** acknowledge that you have been fully informed and are aware of the contagious nature of COVID-19 and the risks it presents to your health and the health of others who you may subsequently come in contact with. In signing this agreement, you unequivocally state the following:

"I voluntarily assume the risk that I may be exposed to or infected with COVID-19 by attending Glass Fusion Collective, Inc., activities and that such exposure or infection may result in personal injury, illness, permanent disability and possibly death. I understand that the risk of my becoming exposed to or infected with COVID-19 while at the Collective facility (facilities) may result from the actions, omissions, or negligence of myself and/or others, including but not limited to Collective board members, employees, instructors, volunteers, agents, representatives, Collective members, students, non-members, Collective facility (facilities) or any Collective program and that the Collective, in its sole discretion, may at any time revoke my access if it determines such revocation is in the best interest of the Collective.

"In consideration of being granted access to Collective facilities or participating in Collective programs as agreed upon by the Collective, I agree to assume all of the foregoing risks and accept sole responsibility for any injury to myself (including but not limited to injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I and any other person that I may come in contact with, may experience or incur in connection with my attendance at any Collective facility or participation in any Collective program.

“Claims”. On my behalf, and on behalf of my family, heirs and assigns, I hereby release, covenant not to sue, discharge, and hold harmless Temple Emanu-El, the Collective, its board members, employees, instructors, volunteers, agents, representatives, Collective members, students, and non-members of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions or negligence of the Collective, its board members, employees, instructors, representatives, volunteers, members, students, non-members, agents, invitees and licensees, whether a COVID-19 infection occurs before, during or after attending the Collective facility or participation in any Collective program.”
